## **Executive Summary/Purpose**

A graduate student's compensation package only partly describes the quality of life experienced by the graduate student during their tenure at Virginia Tech. VT offers competitive assistantship packages to prospective students, but considerable work needs to be done to see the effectiveness of these packages across all of Virginia Tech's campuses where graduate education occurs. The Graduate Student Assembly (GSA) administered a survey to gauge what graduate students were paying to cover the basics every month and are providing some recommendations based on the results.

The Cost of Living Survey was administered by the GSA between February 5th, 2021 to March 13th, 2021. The survey was sent to students via the GLC weekly email, GSA delegate email lists (then forwarded to the respective constituents), and social media. We received approximately 1,100 responses to the survey. The topics that the survey asked were related to stipend information, income taxes, supplemental income, educational costs, rent/mortgage, utilities, childcare costs, groceries, parking/transportation, and health insurance. The full question set can be found in **Appendix A**.

We classified students as Blacksburg, Roanoke, or Greater Washington DC depending on their primary place of work/study. Expenses are reported as either 1) All VT students, 2) Blacksburg students, 3) Roanoke Students or 4) Greater Washington DC Students. The results from this survey indicate the *minimum cost of living per (1) graduate student*.

## **Findings/Recommendations**

- 1. Offer multi-year assistantships, equivalent to the average programmatic time needed to complete a degree.
- 2. 381 responses were from international students (51%).
- 3. All students need to have the option of a 12-month assistantship.
- 4. Evaluate the equity of services provided to graduate students by mandatory fees. The variability of these fees can be found in **Appendix B**.
- 5. Raise the minimum stipend to match the cost of living + additional expenses as indicated by this survey.
- 6. The minimum cost to live for all VT students is \$2136/month. Additionally, respondents have reported spending an average of \$698/month in out of pocket educational expenses (technology, software subscriptions, etc.), out of pocket medical expenses, and/or childcare expenses; these expenses are further described in the Additional Expenses section. This assumes that a student (depending on their situation) may need to spend \$2834/month to afford to live and complete their graduate studies at VT.
- 7. In Fall 2020, there were 3388 assistantships offered to graduate students.
  - a. 987 students that are in departments averaging below \$2136/mo.
  - b. 1454 students making between \$2136-\$2200/mo.
  - c. 72% of students on assistantships are barely making the minimum to live and pay expenses related to education and graduate life at VT.

## **Cost of Living Assessment (All students)**

We used responses from rent/mortgage, utilities, income tax, mandatory fees, parking/transportation, groceries, and health insurance premiums as the minimum requirements to derive a minimum cost of living for graduate students.

We defined utilities as monthly expenses towards gas/heat, electric, water, cellphone, and internet bills.

Parking/transportation costs are defined as monthly payments for parking, insurance, gas, public transit passes, and annual tax payments.

All categories are reported as monthly averages except for groceries (we gave everyone a \$200/month allowance due to the high variability of responses in the category). The average cost of groceries reported by all students is \$329/mo.

We did not factor in expenses such as out of pocket medical expenses, additional educational expenses, or childcare to achieve the <u>minimum cost of living</u> for graduate students. We detail the abovementioned expenses in the **Additional Expenses** section.

The monthly stipend that is needed to meet the cost of living for graduate students at VT is **\$2,136.68**.

The average student has \$20.01 remaining after cost of living expenses are paid.

48.5% respondents report that they are offered a multi-year assistantship with the average of 3.46 years offered.

20.7% respondents report that they work an additional job external to VT working an average of 26.2 hrs/week.

There was a wide variability in Mandatory Fee payments. This is further described in the Limitations section. (A table documenting Mandatory Fee combinations is found in **Appendix B**).

13.4% report that they work an additional job external to VT working an average of 19.2 hrs/week.

The average student lives 6.3 miles from their work location, and it takes 15.6min to commute one-way.

The average student lives 12.3 miles from their work location, and it takes 18.7 min to commute one-way.

## **Cost of Stipend Increase**

As of Fall 2020, there are 3037 students making less than \$2300/month. If the minimum stipend is established to be \$2300/month for a graduate student at VT, we approximate that this will cost the an additional \$6.5million dollars annually.

## Limitations

A total of 1093 students took the survey with 745 students completing the entirety of the survey. Results reported above were based on the 745 complete responses.

\*Mandatory Fees (Blacksburg/Roanoke Students): This was estimated at \$306.44 for all students by totaling in \$1077 comprehensive fees + \$302 Commonwealth Facility Fees and dividing by 4.5 (payment per month).

• In the survey there was a wide range of fees paid by students (\$5-\$1380/month with an average of \$315)

\*\*Mandatory Fees (DC Students): This was estimated at \$83.50 for all students by totaling in \$74 comprehensive fees + \$302 Commonwealth Facility Fees and dividing by 4.5 (payment per month).

• In the survey there was a wide range of fees paid by students (\$47-\$1546/month with an average of \$643)
