Defend VT Students and Employees' Privacy and Security

Virginia Tech's executive administration recently indicated that it plans to use an artificial intelligence system that would comb through every device (computer, phone, etc.) connected to the Virginia Tech network. There has been an indication that this is not limited to equipment owned by the university and would include ANY device relying on the institution's network.

It has been claimed that this would be implemented to detect "cyber-security" threats. However, very little information has been given regarding this misguided policy that harms the privacy and security of VT affiliates. There is now a petition to call on the community to come together, stand up to this policy, and ask the administration important questions regarding this system.

Student Health Insurance Survey

The survey will first ask you questions about your current or past experience with the VT Aetna plan, then questions about your ideal health insurance plan, then finally some questions specifically about the SMI office.

Board of Visitors Meeting Regarding Raising Student Tuition and Fees

The Virginia Tech Board of Visitors held a public comment hearing yesterday regarding their plans to raise student tuition and comprehensive fees. In the meeting they noted that tuition can be raised from 0% - 4.9% and comprehensive fees from 0% - 8.8%.

The Presidents of the Undergraduate Student Senate and the Graduate and Professional Student senate spoke at the meeting and did not support the raising of either tuition or fees. A number of graduate students also shared their experiences about how the costs of being a graduate student at VT has negatively impacted their mental and physical health.

The Board of Visitors will hold a meeting regarding the potential increases on March 20th, 2023. The meetings are open to students at VT and we encourage our community to attend and learn about these important topics.

Students who cannot attend the meeting can still give comments to the Board of Visitors via a comment form. Comments need to be made by March 13th at 11:59pm.


Parking Survey
