#### Resolutions

- 2022-23A Resolution to Provide Sanitary Products for all Campus Bathrooms first reading
  - Potential amendments will be written into new drafts for senators to comment on in the next meeting
  - These amendments are:



- Making explicit that menstrual products should be made available in all restrooms
- Including a new clause that references an interactive campus map highlighting where accessible restrooms are on campus

- Director of Finance
  - GPSS Budget, beginning of the year:

#### UCCGE

- Working on Pathways Program revision and is looking for input from grad students teaching a Pathways course.

- There is no update because half of the subcommittees haven't even met yet.

  - Looking at allowing postdocs, grad students, and adjuncts to be PIs for IRB and IACUC
